Sub: Provision of amenities at stations for persons with disabilities.

Ref: Railway Board's letter No.2012/LM(PA)/3/5 dated 11.09.2012.

Comprehensive instructions on provision of passenger amenities have been issued vide Board's above referred letter. As per Para 9.1 & 9.2 of the letter, short term facilities are to be provided at stations of all categories i.e. A1 to F.

The matter has been considered in Board to review the facilities provided for persons with disabilities at D, E & F category stations and it has been decided that in partial modification to Para 9.1 & 9.2 of Board's letter No.2012/LM(PA)/3/5 dated 11.09.2012 the provision of amenities for persons with disabilities at railway stations shall now be made as per the following details:-
