2.	Taxes & Duties	All the prices are basic rates and exclusive of all Taxes & Duties. All Taxes and Duties (Customs, IGST, GST, etc.) as applicable at the time actual supply, shall be to the account of the purchaser.

3.	Payment terms	As per tender Cl. 12.0 of SCC.
4.	Training	As per tender Cl. 20.0 of ITT to be read with Clause 23.0 of TS.
5.	Service Engineer	As per tender Cl. 21.0 of ITT to be read with Clause 23.0 of TS. After sale service shall include training, commissioning, putting into operation and advise in proper maintenance of the machines.
6.	Inspection	By Purchaser or his nominee as per tender clause 22.0 of GCC to be read with Clause 19.0 of TS.

Commissioning	The machine shall be inspected and commissioned at Plasser India's Work's in Karjan, Gujarat and an Inspection-cum-Commissioning Certificate shall be issued by nominated Railway Officer for release of payment.  However, the contractor shall again do the final calibration and commissioning of the machines at ultimate consignee's location within 90 days of its arrival of final destination in zonal railway as per Clause 11.0 of SCC.

Statutory Clause	Variation	Statutory Variation in taxes and duties, or fresh imposition of taxes and duties by State/Central Governments in respect of the items stipulated in the contract (and not the raw material thereof), within the original delivery period of 23 months, or last unconditionally extended delivery period shall be on Railways' account. Only such variation shall be admissible which takes place after submission of bids i.e. 04.06.2020. No claim on account of Statutory Variation shall be admissible on account of misclassification by the supplier/contractor.
